1. Policy Statement

7. Staff Training and Awareness

All staff and volunteers will receive regular training on:

- Recognising and addressing accessibility barriers.
- Communicating effectively with children who have different needs.
- Understanding and implementing reasonable adjustments.
- Promoting a culture of inclusion and respect.

8. Communication and Engagement

We are committed to providing clear and accessible communication by:

- Using plain language in all materials and providing alternative formats where needed.
- Ensuring parents and carers are informed about accessibility provisions and can discuss any additional support their child may require.
- Encouraging feedback from children, parents, and carers to continuously improve our inclusivity efforts.

9. Tackling Discrimination and Harassment

We have a **zero-tolerance policy** for discrimination, bullying, or harassment of any kind. Any incidents will be taken seriously and addressed in accordance with our safeguarding and disciplinary procedures.

10. Monitoring and Review

We will regularly review our accessibility and inclusiveness practices to ensure they remain effective and compliant with current UK laws. Feedback from children, parents, staff and service users will be used to improve our approach and ensure continuous progress.
